TEXAS ANIMAL HEALTH COMMISSION SUMMARY OF TEXAS REQUIREMENTS FOR ENTRY OF LIVESTOCK (DOMESTIC AND EXOTIC), POULTRY AND RATITES INTO THE STATE AND INTO SHOWS, FAIRS, EXHIBITIONS, AND ASSEMBLIES

NOTE: The following summary is a condensed version of the Texas Animal Health Commission regulations. The regulations will supersede this summary if there is a dispute between the two.

Entering Shows, Fairs and Exhibitions

- A. Livestock, poultry and ratites entering from out of state must meet this state's entry requirements. Texas origin dairy cattle are not required to test for tuberculosis to participate in a show, fair or exhibition within the state.
- B. Animals moving from out of state and entering for exhibition and sale must be accompanied by a certificate of veterinary inspection and a permit for entry when required by the entry regulations. The permit for entry is not required when livestock enter for exhibition and return to the state of origin.
- C. Poultry entered in terminal public exhibition events shall be accompanied by a certificate of source which identifies the flock origin. Poultry entering in a non-terminal public exhibition shall be accompanied by a certificate of veterinary inspection. The certificate of veterinary inspection shall state that poultry have been inspected and are free from evidence of infectious or contagious diseases; that the poultry have been vaccinated only with approved vaccines, and poultry have not originated from an area that has had an active avian disease within 30 days of entry. Poultry entering the state for public exhibition, from other states, must have either a negative flock or individual bird test for Avian Influenza, within 30 days of entry and the results of such test shall be recorded on the certificate of veterinary inspection.
- D. Equine may enter Texas for shows, fairs, exhibitions, or assembly purposes when accompanied by a valid equine interstate passport or equine identification card and a completed VS Form 10-11 showing negative results to an official EIA test within the previous 6 months or a certificate of veterinary inspection and a completed VS Form 10-11 showing negative results to an official EIA Test with the previous 12 months.
- F. Equine originating in Texas and:
 - (1) Entering parimutuel racetracks - Must be accompanied by a certificate of veterinary inspection and a negative test for EIA conducted within 12 months. Foals nursing a negative dam are exempt from testing.
 - (2) Entering a show, fair, exhibition, assembly - Must have a negative test for EIA conducted within the previous 12 months. Foals nursing a negative dam are exempt from testing.
- G. All other livestock, poultry, ratites originating in Texas and:
 - (1) Entering interstate shows, fairs, exhibitions, and assemblies (those functions that permit livestock and poultry from other states to enter for show or exhibition and held in common facilities with Texas origin livestock and poultry of the same species) - Are exempt from an entry permit but must meet the same other requirements as for those entering from out-of-state and be accompanied by a certificate of veterinary inspection.
 - a. Ratites must be individually identified with an implanted electronic device (microchip) and tested for Avian Influenza and Salmonella pullorum-typhoid within 30 days of entry.
 - b. Swine entered in terminal shows are exempt from brucellosis, leptospirosis and pseudorabies requirements.
 - c. Breeding rams origination in Texas are exempt from the brucella ovis test.
 - (2) Entering all intrastate shows, fairs, and exhibitions (those functions that require Texas livestock, poultry and ratites of the same species to be housed and exhibited separate and apart from livestock, poultry, and ratites from out of state) - Are exempt from the entry permit, certificate of veterinary inspection and testing requirements, except poultry must originate from flocks or hatcheries free of pullorum disease and fowl typhoid or have a negative pullorum-typhoid test within 30 days before exhibition.
- H. Rodeo stock from Mexico shall be tested for tuberculosis by an accredited US veterinarian within 12 months thereafter. This is in addition to the entry requirements set out in the section "Cattle Entering the State from Foreign Countries".

EAR TAGS FOR SHEEP AND GOATS

Beginning November 2001, the U.S. Department of Agriculture (USDA) requires that certain classes of sheep and goats have PREMISE identification ear tags applied **BEFORE** they are moved from their farm to be sold in interstate commerce co-mingled with sheep and goats from other farms. Compliance action in Texas will not be taken until April 1, 2002.

Identification requirements extend to:

- All sheep 18 months of age or older.
- All breeding sheep regardless of age.
- Sexually intact show or exhibition sheep and goats.
- All goats 18 months of age or older that are or have been co-mingled with sheep.
- All breeding goats that are or have been co-mingled with sheep.

NOTE: Identification of goats: Tattoos may be used to identify registered or meat and dairy show goats, **as long as the animals are accompanied by their registration papers.** A PREMISE identification number should be obtained and the ear tags should be applied to animals being culled or animals no longer accompanied by registration papers. **For more information and to get your PREMISE identification number and order free tags and tag pliers, call the toll-free designated "tag line" at 1-866-873-2824 or the web site: www.aphis.usda.gov/vs/scrapie.htm**

SUBSTANCE AVOIDANCE PROGRAM

1. The Brazoria County Fair Association shall have the authority to randomly drug test any animal entered into the Fair.
2. Unless otherwise established by the Food and Drug Administration (FDA) or United States Department of Agriculture (USDA), samples collected from show animals will have zero tolerance for any identifiable drug, chemical or feed additive.
3. Exhibitor and parent/guardian must sign an agreement to permit animals to be tested for drugs, chemicals and feed additives.
4. A certification statement must be signed by exhibitor and parent/guardian stating the entry is not, nor will it be, within any withdrawal time relative to the administration of any drug, chemical or feed additive approved by FDA and/or USDA by the time the animal is officially weighed-in at the show.
5. The Livestock Superintendents must be notified prior to administering any drug, chemical or feed additive to any livestock exhibit. The drug, chemical or feed additive shall be documented and include date, product, amount, route, administered by, medical reason for administration and withdrawal time. A Livestock Superintendent must be present at time of administration. A drug, chemical or feed additive may be administered only after consultation and under the direction of a licensed veterinarian.
6. All market steers, swine, goats, and lambs are subject to random drug testing as determined by the Drug Compliance Committee. Animal placings to be tested shall be determined prior to judging. Animals shall be tested for drugs, chemicals, and feed additives.
7. Animals positive to drug tests shall be disqualified and the ranking of animals in the show remain unchanged regardless of drug test results (i.e. Reserve Champion would not be moved to Grand Champion should the Grand Champion be disqualified because of a positive drug test).
8. All sale monies shall be held until drug tests are completed and monies be returned to the buyer of any animal that has positive test results.
9. An exhibitor of an animal producing an analysis with a quantity of diuretic, unapproved growth stimulant or any other unapproved medication will be disqualified and may forfeit all rights and privileges to exhibit livestock in the future at any Brazoria County Fair Association show. This forfeiture will include exhibitor's family members (parents/guardians and brothers/sisters).
10. A security procedure for handling test samples that would preserve the legality of test results shall be followed.

GENERAL LIVESTOCK DEPARTMENT RULES AND 4-H AND FFA JUNIOR SHOW RULES

GENERAL & EXHIBITOR REQUIREMENTS

1. An exhibitor, parent and/or guardian, Agricultural Science Teacher, 4-H Leader or County Extension Agent, who violates any of the following rules will forfeit all privileges and premiums and be subject to such penalty as the Executive Committee may order including disqualification from both the coming up fair and the following fair.
2. All entries must comply with the general rules and regulations of the Fair except as otherwise designated.
3. All animals must be exhibited by the validated exhibitor unless excused by the Livestock Superintendents. In the event of a death in the immediate family, doctor-verified illness, participation in a Texas Education Agency sanctioned activity, or scholastic ineligibility, special permission to allow a substitute exhibitor may be granted by the Livestock Superintendents. The request for substitution must be made to the Livestock Superintendents no later than one (1) hour before the event in which substitution is requested.
4. All Junior Livestock exhibitors must be residents of Brazoria County, a member in good standing in a Brazoria County 4-H Club or FFA Chapter and must be enrolled in a school with this exception: an exhibitor may show at the next Fair following graduation from high school which will be their last show
5. Exhibits must be listed under one owner or exhibitor family.
6. Any member of a Junior Livestock Committee must be a member of the Fair Association.
7. Payment vouchers must be cashed by the close of the Fair on Saturday, October 17, 2009. Vouchers may not be honored after that date.
8. Parents, family members or friends are not allowed in the show arena during show, without permission from the Chairman or Co-Chairman of the show.

ELIGIBILITY

9. Prior to the opening of the Fair, the Fair Association will make available to the exhibitors a form that may be filled out by the appropriate school official which will fulfill requirements of this rule. Documentation on official school district letterhead may be substituted. This information must be received prior to the issue of the livestock exhibitor wristband.
10. In the event the validated exhibitor is scholastically ineligible under the no pass/no play rule, a substitute exhibitor may be allowed provided the ineligible exhibitor presents a signed document from their school prior to the opening of the Fair. The document must state that the owner of the animal is scholastically ineligible and will not be eligible to show the animal. It must be prepared and signed by the appropriate school registrar. Once the document has been presented to the Livestock Office the Livestock Superintendents will use their own discretion as to whether a substitution will be allowed.
11. If a positive decision is rendered, the substitute exhibitor shall be a family member. If a family member is unable to show the exhibit, a member of the same 4-H Club or FFA Chapter may be substituted. If a member of the same 4-H club or FFA chapter is unable to show, a substitute exhibitor, approved by the Livestock Superintendents, may be allowed to exhibit the animal. The substitute must also meet all requirements of a junior livestock show exhibitor in the Brazoria County Fair. It is the responsibility of the exhibitor and exhibitor's family to verify scholastic standing and take the appropriate action to assure that the requirements of this rule are met.

ENTRY REQUIREMENTS

12. Application for entry for animals must be made out on printed forms provided by the Fair Association to the County Extension Agents, 4-H Leaders, Agricultural Science teachers and exhibitors. All entry forms and fees are to be turned into the Fair Office by the respective group leader or his/her representative as a complete club's entries. Summary sheets are to accompany the club's entries. All entry forms, fees and summary sheets must be in the Fair Office by **5:00 p.m., Friday, September 4, 2009**. No entries will be accepted after this date. All entry forms **MUST** be signed by the correct authorized person verifying the eligibility of each exhibitor and the exhibit. All appropriate blanks on the entry form must be correctly filled in. Market steers, hogs, lambs, goats, turkeys, and rabbits, as well as Commercial Heifers, may be entered as a family exhibit. All eligible members of a family exhibit must be listed on all validation and entry forms. Exhibits entered as a family exhibit shall declare which exhibitor will show which exhibit at the check-in or weigh-in at the Fair. Junior Sale Certification forms must be completed and signed by exhibitor and parent/guardian in all sale classes - (steers, hogs, lambs, turkeys, broilers, market rabbits, and commercial heifers).
13. Showmanship: Times will be set by each department. Ages as follows: Sub-Junior (8-10 years old), Junior (11-13 years old), and Senior (14-19 years old). All exhibitors entered in or called back for showmanship must show or exhibit his or her own animal. Exhibitor must be the owner of the animal they exhibit in showmanship, and the animal must be entered in the show. **AN EXHIBITOR MAY RECEIVE MORE THAN ONE SHOWMANSHIP AWARD DURING ANY ONE YEAR; HOWEVER, NO EXHIBITOR MAY RECEIVE THE SAME SHOWMANSHIP AWARD TWO (2) YEARS IN SUCCESSION.**
14. A maximum of three (3) entries per exhibitor per department for market shows.
15. In cases of conflict, individual departmental rules will take precedence over General Livestock Rules.
16. Any animal entered and stalled in Livestock Division may be used for judging purposes by Junior Livestock Judging Committee.
17. **There will be no refund of entry fees.**

CARE & FEEDING

18. **FEEDING IN THE STALLS IS PROHIBITED.**
19. Sand bedding will be used.
20. No Junior exhibitors will be permitted to spend the night on the Fairgrounds during the fair except at designated areas. Exhibitors will be released from responsibility of caring for their livestock between 12 midnight and 6:00 a.m. each day except in special cases such as the auction sale, at which time the exhibitors will be released immediately following the clean up after the sale. The Fair will furnish night security who will be on duty in the Livestock Barns all night.

21. Exhibitor must feed, bed, care for, and keep his/her animal and stall properly cleaned during the entire show. All halter cattle will be cross-tied. All stalls and pens must be clean before 11:00 am each morning. All exhibits are to be in respective stall or at tie-outs after 11:00 a.m. each day. All vehicles involved in the care of animals and exhibitions must adhere to the Livestock Gate schedule. Exercising of all animals, cattle and sheep, is restricted to the livestock area. Beginning Friday night upon check-in, no one will be allowed in the Cattle Barns, Swine Barn, Lamb Barn, Scramble Barn, or Poultry Barn between the hours of 12 midnight and 6:00 a.m.
22. **Livestock feeding gate will be open 6:00 a.m. – 9:00 a.m. daily.**
23. All agricultural exhibits must have been cared for by the exhibitor or exhibitor family under the direct supervision of his/her County Extension Agent, 4-H Leader, or Agricultural Science Teacher.
24. Beginning at validation and ending at fair check-in, no agricultural exhibit will be allowed to leave Brazoria County for longer than seven (7) days without prior written authorization of a Brazoria County Fair Association Livestock Superintendent. Livestock exhibits will be subject to random checks by Livestock Superintendents or delegates of the Livestock Superintendents. Any exhibitor found not in compliance with this rule will be subject to penalty outlined in Rule # 1 of the General Livestock Rules. All exhibits of livestock and poultry must have been owned by the exhibitor or exhibitor family for at least 90 days prior to the fair unless otherwise specified.
25. Grand and Reserve Champions from each department must be placed and remain on Champion Row after their show for the remainder of the Fair. The animal or exhibit may be removed for feeding and cleaning of the stall area. Stall areas need to be kept clean at all times. Champion Row will be designated by the Livestock and General Sales Superintendents.
26. All paved areas around the livestock barns are designated for the use of livestock grooming and/or livestock feeding only. These areas shall not be used for any other purposes. **No tents, awnings, or any other material shall be used around or along the Livestock Barns.**

SHOW BOXES, DISPLAYS & EQUIPMENT

27. Show boxes, tack, feed, hay, feeding equipment or watering equipment shall be kept clear of any designated area, aisle or walkway. No more than one show box will be allowed per exhibitor. Show boxes shall not extend into the paved aisle. Show boxes exceeding the space available in the barn will be moved to a designated area. The Livestock Superintendents will make this determination. Trimming chutes and tables must be removed from all exhibit areas immediately after judging of the various departments.
28. There will be no alterations to any facilities in the livestock division without the expressed written consent of the Livestock Superintendents. Any club, chapter or group that places exhibits in any of the barns must plan to do so without altering the facility. Minor alterations, no matter how small, must be approved prior to being done.
29. Each club will be limited to bring onto the Fairgrounds one trim chute for the first five head of cattle entered and one trim chute for each additional five head of cattle entered. Trim chute tags will be issued to FFA Chapters and 4-H Clubs per the cattle entries. Untagged trim chutes will be removed from the Fairgrounds.
30. Any display exceeding the 4' X 8' assigned area will not be eligible for judging and awards.
31. Displays may be taken down but not removed before **1:00 pm, October 18, 2009.**

See Livestock Release Committee for more information on release of displays.

RELEASE

32. No exhibit may be removed from the Fairgrounds before **7:00 am, Sunday, October 18, 2009** unless a release is secured from the Respective Show Committee. Exhibitors may remove livestock **Sunday, October 18, 2009, 7:00 am to 11:00 am.** Animals that become ill during the Fair will not be released until the nature of the illness has been diagnosed by a licensed veterinarian. **THE FAIR ASSOCIATION WILL NOT BE RESPONSIBLE FOR ANY ANIMAL NOT REMOVED BY 11 A.M. SUNDAY. THE FAIR IS NOT RESPONSIBLE FOR ANY ANIMAL DURING THE FAIR.**
33. All Grand and Reserve Grand Champions from Junior Livestock Department will remain until closing of the Fair.
34. All animals which are unruly or uncontrollable will be released and must be removed from the Fairgrounds. Such ruling will be made by the chairmen of the committee involved and the livestock superintendents.

See individual department rules for more information on early release.

DRUG COMPLIANCE

35. Unless other wise established by the Food and Drug Administration (FDA) or United States Department of Agriculture (USDA), samples collected from show animals will have zero tolerance for any identifiable drug, chemical or feed additive.
36. The exhibitor and immediate family of a animal producing analysis of an unapproved medication will be disqualified and may forfeit all right and privileges to exhibit livestock in the future at any Brazoria County Fair show. This forfeiture will include exhibitor's family members (parents/guardians and brother/sisters). The Livestock Superintendents must be notified prior to administering any drug, chemical or feed additive to any livestock exhibit. The drug, chemical or feed additive shall be documented and include date, product, amount, route, administered by, medical reason for administration and withdrawal time. A Livestock Superintendent must be present at time of administration. A drug, chemical or feed additive may be administered after consultation and under the direction of a licensed veterinarian. **See Substance Avoidance rules for more information.**

PROTESTS

37. Protests must be made in writing and be accompanied by a deposit of \$250.00, which will be forfeited if the protest is not sustained. In the case of any protest concerning livestock substance abuse, the protest must be made in writing and be accompanied by a deposit of \$250.00, which will be forfeited if the protest is not sustained. An additional \$500.00 must accompany the written protest, to cover the drug test, DNA testing and related expenses, and this additional fee of \$500.00 is not refundable, regardless of the outcome. In the event the information presented to the Disciplinary Committee is the result of an internal investigation of wrong doing, the protest fee shall be placed in escrow, and charged to the appropriate department. Any person who violates any of the general rules or special rules as published in the premium list and catalog will forfeit all

privileges and premiums and be subject to such penalty as the Disciplinary Committee may order. Unacceptable conduct and failure to cooperate with security personnel, employees or officials of the Fair Association in all matters of policy will be subject to disciplinary action. The Disciplinary Committee has the right and the responsibility to hear and investigate the evidence presented by both sides and then reach a binding decision. The parties involved have ten days to exercise the right to appeal to the Disciplinary Committee if there is additional evidence to present. The final decision of the Disciplinary Committee may be appealed to the full Executive Committee if request for appeal is made in writing within the specified ten-day period.

ANIMAL HEALTH RULE

38. All Commercial Heifers that are 12 months of age or older must be palpated.
39. No bangs testing, no palpating, and no Artificial Inseminating on the fairgrounds.
40. HEALTH - See Texas Animal Health Commission Rules in the fair catalog.
41. Brucellosis Testing – All Commercial Heifers 18 months of age or older must be brucellosis tested within 30 days prior to the Commercial Heifer Auction.
42. Sheep and goats Premise tags – See Texas Animal Health Rules in the fair catalog.

JUDGING

43. Merit must exist to win an award.
44. Any exhibitor attempting to interfere with the judges before the decision is rendered will automatically disqualify his/her entry in that department.
45. **The decision of the judges is final.**
46. Any person other than designated Weigh Master who interferes with scales during any official weighing process will cause Exhibitor to be automatically disqualified.
47. The judges will pass on the merits of the animals exhibited and their soundness.
48. Animals showing, in the opinion of the judges, signs of having been operated upon or tampered with for the purpose of concealing faults in conformation or with intent to deceive relative to the animal's soundness, will be disqualified.

SCRAMBLE CALVES

49. All Scramble Steer and Scramble Heifer exhibitors must be in good standing within the respective scramble department to be eligible to exhibit in any Junior Livestock Show/Department. Failure to meet all Scramble Show requirements will result in the exhibitor being prohibited from exhibiting in any Livestock Show/Department until such time as all requirements are met or the dollar value of the Scramble Certificate is refunded to the Brazoria County Fair Association.

SPECIAL AWARDS
4-H AND F.F.A. MEMBERS

1. Only Brazoria County 4-H and FFA Members are eligible for these awards.
2. A High Point Award will be given to the boy or girl who accumulates the most points in the Junior Livestock Show. This award cannot be won two years in succession. In case of repetition, next in line will receive the award.
3. The Second High Point Award will be given to the runner-up boy or girl that accumulates the most points in the Junior Livestock Show. Third through tenth places for High Point Award will receive recognition.
4. Points will be given for one entry in each livestock department. An additional one point per department entered will be given each exhibitor for participation. Point systems will be as follows:

1st Place	10 Points	6th Place	5 Points
2nd Place	9 Points	7th Place	4 Points
3rd Place	8 Points	8th Place	3 Points
4th Place	7 Points	9th Place	2 Points
5th Place	6 Points	10th Place	1 Point

If a tie exists, the exhibitor with the most participation points will be the winner. If there is still a tie, the exhibitor with the most first places will be the winner. It will be necessary for exhibitors to fill out an application form listing all entries shown. This form **MUST BE SIGNED BY THE EXHIBITOR AND HIS/HER PARENTS** and turned in by 5:00 pm on Friday, October 16, 2009 to the Livestock Office.

5. Recognition will be given to the Grand Champions and Reserve Grand Champions of the Market Steer, Market Swine, Market Lamb, Market Goat, Commercial Heifer, Commercial Heifer Pen of Three, Scramble Heifer, Scramble Steer, Breeding Beef Heifer, Pen of Market Rabbits, Single Market Rabbit, Market Turkey, and Market Broiler departments. Awards will be presented to the Grand Champion Swine Carcass, Steer Carcass, Lamb Carcass, Goat Carcass, Breeding Ram, Breeding Ewe, Best 6 Class Rabbit and Best 4 Class Rabbit.
6. Sub-Junior (ages 8-10), Junior (ages 11-13) and Senior (ages 14-19) Showmanship awards will be presented in the Commercial Heifer, Market Swine, Market Lamb, Market Steer and Breeding Beef departments. Only one Showmanship award will be presented in the Scramble Heifer, Scramble Steer and the Breeding Sheep departments. Ages will be determined as of October 1, 2009. Winners will be selected on merits received for fitting their own animals during their respective judging events. An exhibitor may receive more than one showmanship award during any one year; however, **no exhibitor may receive the same award two years in succession.**
7. A High Point Breeding Rabbit trophy will be presented to the exhibitor accumulating the most points in the Breeding Rabbit Department.
8. An award will be presented to the exhibitor accumulating the most points in the Sheep department. No exhibitor may win this award two consecutive years.
9. Awards will be given to the 4-H or FFA Club with the first and second place Best Display. There will also be a first and second place Herdsman Award given for the best kept areas by a club or chapter in the Cattle Barns.
10. Awards will be presented to the first and second place Scramble Heifer and Scramble Steer reports.
11. All department results should be turned in to Awards Committee by 7:00 pm, Thursday, October 15, 2009 to allow Awards Program planning to be completed.
12. **Payment vouchers must be cashed at the Fair Treasurer's Office by the close of the Fair on the last Saturday October 17, 2009.** Vouchers may not be honored after this date.

RULES

1. The entries and awards in this department are subject to General Livestock and Fair rules printed in this catalog unless otherwise specified.
2. Heifers entered in all other Junior Heifer Shows may be shown in Junior Breeding Beef with proper entry and entry fee paid for Junior Breeding Beef.
3. There are **NO** family entries in the Junior Breeding Beef Show.
4. All Breeding Beef animals must be approved by an Agricultural Science Teacher, a 4-H Leader, or a county agent before bringing it to the show.
5. Animals entered in this department must be registered in the records of their respective breed association (in the name of the exhibitor) on or before **July 1, 2009**.
6. The exhibitors of registered animals must **submit a copy of registration papers at the time of check-in on Friday or Monday. All heifers without registration papers will be shown in crossbred classes.** No substitution after entry deadline. No substitutions at check in.
7. No bulls will be shown in the Junior Breeding Beef Show.
8. Merit must exist to win an award.
9. Showmanship awards will be given in the following classes: Sub-Junior (ages 8-10), Junior (ages 11-13), and Senior (ages 14-19). The Showmanship Contest will begin promptly at 10:00 a.m. with the show immediately following. All exhibitors entered in this show may participate in the Showmanship Contest; however, exhibitor must be the owner of the calf they are showing in the Showmanship Contest and the calf must be entered in the Breeding Beef show in the name of the exhibitor. **All exhibitors interested in showmanship are requested to sign up at time of check-in.** Cattle need not be fitted for the Showmanship Show. Winners will be announced immediately after the contest. No exhibitor can win the same division of showmanship two years in succession. **An exhibitor may receive more than one showmanship award during any one year; however, no exhibitor may receive the same award two years in succession.**
10. All animals must be stalled using safe cross ties defined as 3/8" or larger durable rope.
11. There will be no sift for the Junior Breeding Beef Show.
12. For exhibitor eligibility requirements, see General Livestock Department rules.
13. All exhibitors in the Junior Breeding Beef Show must wear their show numbers pinned to the back of their shirt or blouse.
14. Purebred registration requirements according to individual breed associations are as follows:
 - A. **AMERICAN DIVISION:**

 - Shorthorns:** must be purebred and registered with the American Shorthorn Association (ASA)
 - Angus:** Must be registered in the Association herdbook.
 - All Other Breeds:** English Division animals with registration papers that do not meet above requirements. Example – Herefords, Polled Herefords or percentage animals.
 - C. **EXOTIC DIVISION:**
 - Limousin:** must be 7/8 percentage Limousin or greater and must be registered with the North American Limousin Foundation.

EAR TAGS FOR SHEEP AND GOATS

Beginning November 2001, the U.S. Department of Agriculture (USDA) requires that certain classes of sheep and goats have PREMISE identification ear tags applied **BEFORE** they are moved from their farm to be sold in interstate commerce co-mingled with sheep and goats from other farms. Compliance action in Texas will not be taken until April 1, 2002.

Identification requirements extend to:

- All sheep 18 months of age or older.
- All breeding sheep regardless of age.
- Sexually intact show or exhibition sheep and goats.
- All goats 18 months of age or older that are or have been co-mingled with sheep.
- All breeding goats that are or have been co-mingled with sheep.
-

NOTE: Identification of goats: Tattoos may be used to identify registered or meat and dairy show goats, **as long as the animals are accompanied by their registration papers.** A PREMISE identification number should be obtained and the ear tags should be applied to animals being culled or animals no longer accompanied by registration papers. **For more information and to get your PREMISE identification number and order free tags and tag pliers, call the toll-free**

5. Steers must weigh a minimum of 900 pounds at the Fair weigh-in. There will be no maximum weight. If a steer does not weigh 900 pounds, the steer will be removed from the scales, scales balanced, the steer walked back around the scales by the exhibitor and a designated committee person, and re-weighed one time only.
6. All steers will be weighed and classified Saturday, October 10, 2009. There will be no tooting of steers.

1. All non-placing animals must leave the grounds on **Early Release** Sunday, October 11, 2009. Non-placing animals consist of any hog not receiving a ribbon during the judging of animals. Exhibitors failing to remove non-placing animals shall be disqualified from next year's Swine Show.
2. All placing animals (those receiving ribbons) must remain for the duration of the fair. Placing animals will be moved to other pens at the close of **Early Release** (Sunday, October 11, 2009) in order to accommodate other departments of the fair.
3. The entries and awards in this department are subject to General Livestock and Fair Rules printed in this Catalog, unless otherwise specified.
4. Exhibitors will be required to keep their pens in a clean condition by removing all waste, feed and water pans. No bedding hay or litter may be used in the pens at any time. The barn area will be inspected daily. All items found in pens containing animals will be removed and placed at the wash racks.
5. Exhibitors must furnish feed (ground or palletized), feeders, and water containers. Exhibitor are responsible for feeding and caring for their exhibits through the duration of the fair. Any Exhibitor failing to feed, water, or keep pen clean will be issued a written warning. After the third written warning, the Exhibitor shall remove their exhibit from the Fairground premises and shall be disqualified from next year's Swine Show.
6. Hogs will not be clipped in the Swine Barn or on Fairground premises. Any Exhibitor failing to comply shall be disqualified from the Swine Show and the exhibit shall be removed by the Exhibitor at Early Release on Sunday, October 11, 2009.
7. All hogs must be validated and tagged by a Swine Committee member on **Saturday, JULY 11, 2009** from 7:00 a.m. to 10:00 am at the Fairgrounds.
8. Each Exhibitor may validate and show 2 hogs, only selling one. The highest placing hog must sell. In the event the Exhibitor has two equally-placed hogs. The Swine Committee must be notified within one hour of the close of the Swine Show, which hog the Exhibitor chooses to sell. Otherwise, the Swine Committee Chairman will determine which hog will sell.
9. If the Exhibitor has more than one hog in the class, any eligible 4-H or FFA member may show one of the hogs for the exhibitor. The Swine Committee must be notified prior to the start of the show.
10. All hogs may be validated and entered as a Family Exhibit. Exhibitors must declare at weigh-in which hog they will show at the Fair.
11. For exhibitor and animal protection, all hogs and trailers must be clean and sanitary upon arrival at tag-in gate. All Animals and/or trailers that are found to be unsanitary upon inspection will be turned down for validation unless properly presented by 10:00 am. Determination of cleanliness will be decided by the committee.
12. **No re-tagging will be done at the weigh-in without prior notification by Exhibitor to the committee chairman or Co-chairman.**
13. Barrows or Open Gilts may be shown in this department. There will be eight classes divided as equally as possible by weight, with a weight range from **215 pounds to 270 pounds**.
14. The top two placing hogs in each class will be reweighed following judging and they shall not exceed ten pounds of **individual official weight**. If an animal exceeds 10 pounds, it shall be disqualified and the class placings will move up one place.
15. After the last class has been judged, Sub-Junior (ages 8-10), Junior (ages 11-13), and Senior (ages 14-19) Showmanship Contest will be open to all Exhibitors that wish to participate in the Showmanship Contest. Winners will be announced immediately. **SEE GENERAL LIVESTOCK RULE #12.**
16. All market hogs will be weighed by the Exhibitor on the designated scales provided by the Swine Committee. Each Exhibitor shall return the weigh slips to the Swine Committee not later than 7:30 pm on Friday, October 9, 2009.
17. The Swine Committee will designate Pen Assignments. Pen Assignments will be selected at random by the Swine Committee. Pen Assignments will be posted Saturday, October 3, 2009, at 8:00am. 6. Any late or incorrectly marked **score cards or scan sheets** that are turned in for scoring will be disqualified. A blank card or scan sheet will result in a score of 0 for that class or group of questions.
7. **ALL JUDGING CONTESTANTS SHOULD REPORT DIRECTLY TO THE AUDITORIUM UPON ARRIVAL AT THE FAIRGROUNDS; FAILURE TO DO SO MAY RESULT IN DISQUALIFICATION OF THE INDIVIDUAL.**
8. Team members and coaches will meet between 6:45 am and 7:15 am on Saturday, October 17, 2009 in the stands of the Auditorium. At this time, the coaches will receive their judging lists with the contestants assigned group and contestant number.
9. No score cards or scan sheets will be returned. Computer printout results may be available on the day of the contest. To insure that your club or chapter receives the official results, please turn in a self-addressed, stamped envelope to the judging committee at the check-in table; please include a team roster for easier reference.
10. There should be no talking or interactions of any kind between judging contestants during the contest; this includes parents and judging coaches. All parents and coaches are asked to refrain from entering the judging area until after the contestants have been dismissed. One warning will be given to contestants for talking; the second offense will result in disqualification.

RULES

1. The Brazoria County Fat Stock and Fair Association, Inc. will not be responsible for any accidents which may occur to any participant in the Calf Scramble. All information requested on the minor's release must be complete. Both parents must sign the release; however, if the parents are divorced or one is deceased, the signature of the custodial parent is sufficient. The notation "divorced" or "deceased" must be made in the space provided.
2. Contestants for the Calf Scramble must be carefully selected from Brazoria County FFA Chapter and 4-H Club members. Contestants must be in good standing with their organization. All applications will be accepted on Official Brazoria County Fair Association Application Form only submitted through the respective Brazoria County FFA Chapter Leader or Brazoria County 4-H Leader. Absolutely no substitutions will be made in the participant lists after entry forms are received by the Brazoria County Fair Association. No changes will be made in the schedule, once you have been assigned a rodeo performance. The 2009 Scramble Committee has the final approval of all applicants and those selected will be notified of their acceptance as a participant prior to Fair week. No refunds will be made to applicants that do not run in the scramble.
Ages: A contestant must have reached his/her 12th birthday by October 1, 2009, but not his/her 18th birthday by October 1, 2009. **Weight:** The Fair Association suggests that a participant's minimum weight be not less than 100 pounds. **Health:** Participants who report to the Scramble must be in top physical condition at time of scramble in order to run for a calf. Any contestant appearing with broken limbs, etc. will automatically be disqualified and an alternate will be put in his/her place. Any applicant awarded a calf in the previous year can return the following year and be listed as an alternate for the year. **Note:** This means it is possible for an applicant to run two years in a row. First year as an applicant, second year as an alternate. Alternates will be qualified as determined by the discretion of the committee majority.
PARTICIPANTS WHO ARE NOT AT THEIR DESIGNATED MEETING TIME FOR ROLL CALL WILL BE PAGED OVER THE INTERCOM SYSTEM ONCE, AND WILL HAVE FIVE (5) MINUTES TO REPORT AND BE ACCOUNTED FOR OR WILL BE REPLACED BY AN ALTERNATE.
3. Participants and/or parents **shall not** approach sponsors or committeemen for special consideration.
4. For contestant eligibility requirements, see General Livestock Department rules.

ARENA RULES

5. Contestants and calves will be placed in the Arena as directed by the Chairman of the Committee.
6. The Fair Association will supply each contestant with a rope halter to be used in the calf scramble. Halter must be placed on the head of the animal in the usual way, which is behind the calf's ears, over the bridge of the nose, and under the chin. For the safety of the animal, no halter can be placed around the neck of the animal.
7. At no time will a contestant be permitted to tie the rope to his/her body or belt.
8. Each contestant will attempt to catch and halter one of the calves released. The contestant catching a calf is required to lead it across the finish line without aid.
9. If a contestant has hold of a calf, no other contestant will be allowed to touch the calf unless it breaks away.
10. If a contestant catches a calf by the tail, he/she will be given a reasonable amount of time to work around to its head; otherwise, the referee will order them to let the calf go.
11. If two or more contestants catch the same calf, a committee member can determine who had the calf first and will ask the other contestant to let go. If no committee member can make the determination the calf will be turned loose.
12. A contestant who secures and properly halters a calf and leads it across the finish line will be declared a winner when so indicated by the referee.
13. Undue roughness by the contestant will not be tolerated. Poor sportsmanship automatically disqualifies any contestant.

DUTIES AFTER WINNING A CALF

14. Winners must exhibit their calves at the 2010 Brazoria County Fair in the Scramble Calf Shows.
15. Should any contestant participating in the Calf Scramble fail to catch because of unusual or extenuating circumstances and is then awarded a calf by some sponsor, said contestant will participate in all special awards offered to the scramble winners. The contestant must care for the calf under the Calf Scramble Rules, and the donor will become a Calf Scramble Sponsor.
16. A contestant catching a calf in the Calf Scramble, or otherwise being declared a winner, will receive a purchase certificate with which to purchase a calf of his/her own choice.
17. To enable each individual winner to make the decision as to the breed of calf they desire to purchase, substitute calves will be used in the arena for the Calf Scramble.
18. Original thank you letter to the sponsor, along with an unsealed, stamped envelope must be turned in to the Scramble Office before the close of the Fair so that participant can receive his/her purchase certificate. The Fair Office will mail the letter to the Sponsor.
19. If all rules are not complied with, the committee may disqualify the participant and request a refund. Disciplinary action may be taken according to General Livestock Rule #1. Should any of the rules and regulations as published in the Brazoria County Fair Catalog not be met, the FULL REIMBURSEMENT of certificate amount will be the responsibility of the parent/guardian, to be paid or arrangements made, by the end of the Scramble Check-In (see Scramble Calf Shows for date and time). If payment or arrangements have not been made by the stated deadline, the participant

- will be deemed "NOT IN GOOD STANDING" and unable to participate in any and all other Brazoria County Fair competitions). See General Livestock Rule # 48. If full reimbursement is not received, legal action will be taken.**
20. The calf must be purchased by the winner not later than April 15, 2010 following the 2009 show. When the contestant has selected the calf he/she desires, the purchase certificate should be given to the seller. All information requested on the purchase certificate must be completed. Send purchase certificate to the Brazoria County Fair Association, P.O. Box 818, Angleton, Texas 77516.
 21. The scramble calf must be validated and ear tagged at May validation. See the Scramble Calf Show rules (Department "S") for the required County Fair Entry Fee information.
 22. Failure to comply with the rules of this Department will result in the exhibitor not being allowed to participate in this Department the following year.

3. Winners may purchase the animal of their choice in accordance with the classes below.
4. The heifer or steer must be purchased by the winner not later than April 15, 2009 following the 2008 show. When a contestant has selected the calf he/she desires to purchase, the purchase certificate should be given to the seller. All information requested on the purchase certificate shall be completely filled in. The seller has 60 days to send the Purchase Certificate to the Brazoria County Fair Association, P.O. Box 818, Angleton, Texas 77516. Payment shall be made to the seller within fifteen (15) days of receipt of the completed Purchase Certificate. The payment will not exceed the amount of the certificate. If the seller elects to wait more than 60 days, this rule of the Brazoria County Fair Association of payment being made to the seller within fifteen (15) days does not apply.
5. Once each month, starting May 15, the contestant is required to complete a progress report on his/her animal. This report must be submitted in the format provided by the committee. The original report and one copy, along with a stamped, unsealed sponsor-addressed envelope shall be turned in to the Fair Office by the 15th of each month. If the 15th of the month falls on a weekend, the report and/or essay must be turned in before the close of business on the Friday before the 15. Scramble Steers will be validated 7:00 am to 12:00 am. After validation date there will be no changes allowed of animals that are to be shown.
9. All Scramble Calves must show in the Scramble Calf Show and must be in assigned stall in the Scramble Barn at all times except for showing, feeding, and bathing.
10. Feeding time for Scramble calves will be between 6:00 a.m. and 11:00 a.m., and 5:00 p.m. and 8:00 p.m. daily.
11. All Scramble Barn stalls must be cleaned each morning by 11:00 a.m., and as needed thereafter.

RULES

1. The entries and awards in this department are subject to General Livestock and Fair rules in this catalog unless otherwise specified.
2. Any breed or crossbreed goat (females or wethers) will be eligible. Any female goat showing signs of pregnancy will be disqualified as determined by the judge.
3. No goats will be allowed on the fairgrounds before 1:00 p.m., Sunday, October 11, 2009.
4. Goats must be dehorned or tipped prior to arrival at the fairgrounds. If tipped, horns must be no smaller than the diameter of a dime. **No tipping of horns will be allowed on fairgrounds.**
5. Goats must weigh no less than 60 pounds and no more than 120 pounds at weigh-in. Goats will be divided into ten (10) weight classes as evenly as possible by weight at weigh in. Goats are allowed one weigh in only. Sifted goats must be removed from the fairgrounds immediately.
6. First and second place goats in each class will be weighed immediately after placing. Goats weighing more than five (5) pounds over the weigh-in weight will become non placing goats.
7. All goats must be slick shorn from the knees and hocks up with the exception of the tail switch.
8. Goats will be shown with a chain collar. No bracing will be allowed.
9. All market goats to be shown at the Fair must be validated (ear tagged) on July 11, 2009, from 7:00 a.m. to 10:00 a.m.
 - a. Each exhibitor may validate any number of goats, but may show no more than three (3) Market Goats.
 - b. If an exhibitor has more than one goat in a class, another eligible 4-H or FFA member may show one of the goats for the exhibitor.
 - c. All goats may be validated and entered as a Family Exhibit. Exhibitor must declare which goat he/she will show at time of weigh-in.
 - d. All Sexually intact goats must have Premise identification ear tags or meet identification requirements from State and Federal Scrapie requirements at validation and through the show (see Texas Animal Health rules in this catalog).
 - e. **If an ear tag is lost (or removed), exhibitor must notify the Committee Chairman immediately. No re-tagging will be done without proper notification by exhibitor to the Committee Chairman.**
10. Exhibitors will be required to keep their pens in clean condition by removing all waste and feed. Water containers can remain in stalls only if secured to prevent tipping over. No bedding may be used in the pens at any time. The barn will be inspected daily. All items (excluding secured water containers) found in pens with animals or in aisle, will be removed.
11. Exhibitors must furnish feed, feeders, and water containers and be responsible for feeding and care of their exhibits through the duration of the show. Any exhibitor failing to feed, water, or keep pens clean will receive written notice. After the second written notice, exhibitor will be barred from showing in next year's Market Goat Show.
12. After the last class has been judged, individuals selected for Sub-Junior (ages 8-10), Junior (ages 11-13), and Senior (ages 14-19) showmanship will compete in a Showmanship Contest. Winners will be announced immediately. **See General Livestock Rule #12.**
13. Any exhibitor having more than one goat eligible for the Junior Livestock Auction must sell their highest placing goat.
14. For exhibitor eligibility requirements, see General Livestock Department rules.
15. All rules of this department must be adhered to or goats will be sifted.

EAR TAGS FOR SHEEP AND GOATS

Beginning November 2001, the U.S. Department of Agriculture (USDA) requires that certain classes of sheep and goats have PREMISE identification ear tags applied **BEFORE** they are moved from their farm to be sold in interstate commerce co-mingled with sheep and goats from other farms. Compliance action in Texas will not be taken until April 1, 2002. Identification requirements extend to:

- All sheep 18 months of age or older.
- All breeding sheep regardless of age.
- Sexually intact show or exhibition sheep and goats.
- All goats 18 months of age or older that are or have been co-mingled with sheep.
- All breeding goats that are or have been co-mingled with sheep.

NOTE: Identification of goats: Tattoos may be used to identify registered or meat and dairy show goats, **as long as the animals are accompanied by their registration papers.** A PREMISE identification number should be obtained and the ear tags should be applied to animals being culled or animals no longer accompanied by registration papers. **For more information and to get your PREMISE identification number and order free tags and tag pliers, call the toll-free DESIGNATED "TAG LINE" AT 1-866-873-2824 OR THE WEB SITE:**

2. Entries are open to the state.
3. The owner of each breed entry over 8 months of age must submit a copy of that entry's registration papers. For each breed entry under 8 months the owner must submit a herdhandler and copies of sire and dam registration papers. All registration papers must accompany the entry form and be turned into the Fair office by entry deadline or animal will be shown in a crossbred class. **Registration papers will be checked with entries. All animals without papers will be shown in crossbred class.**
4. Number of entries per exhibitor will not be limited. Each animal may show in only one class. **No family entries will be accepted.**
5. All Other breeds will include breeds not listed; check Purebred Registration Requirements. Crossbred animals include all unregistered animals and all entries not complying with rule #3.
6. Classes may be split based on the number of animals in a class.
7. All out of county and ranch entries **must** check in on Friday morning of the show, even if pre-entered to receive back numbers and release forms. **Only bulls, out-of county entries and ranch entries that come in on day of show will be released after the judging of the show on Friday, October 16, 2009. No other animals, including Scramble Heifers, will be released.**
8. **There will be no releases later than one hour after the conclusion of the Open Beef Show. Bulls will be released after they show.**
9. All exhibitors that show cattle in the open show must meet age requirement of eight (8) years of age or in the third grade except for exhibitors entered in the Pee Wee Showmanship.
10. Pee Wee Showmanship will be held before the Open Beef Show (8:30 a.m.). There will be a \$5.00 entry fee for Pee Wee Showmanship contestants. Only exhibitors not eligible for any junior show competition due to age, but no exhibitor younger than five (5) years of age will be eligible to compete in the Pee Wee Showmanship contest. Pee Wee Showmen should be able to control their animal with minimal show ring supervision. **Pee Wee Showmen are not allowed to exhibit in the Open Beef Show.** Last year's Pee Wee Showmanship winner will not be allowed to compete in this year's competition. Late entries will be accepted until 8:00 a.m. the day of the show.
11. All bulls are required to have a nose ring or nose lead. No bulls will be allowed in Livestock Area until show day, October 16, 2009.
12. All bulls **must** be removed from the fairgrounds at the conclusion of their showing. No bulls will be permitted to stay on the fairgrounds overnight.
13. **All Brazoria County Junior Exhibitors must check-in at one of the first two check-ins, the first Friday, October 9, 2009 or Monday, October 12, 2009. The check-in on show day is reserved for out-of-county and ranch entries only. Back numbers shall be picked up at time of check-in for junior exhibitors.**
14. **No substitutions will be made after entry deadline.**

Entries for FC classified cattle, such as F-1, 3/4 Hereford, or 3/4 Brahman will be shown in the Crossbred classes.

Brahman: must be registered with the American Brahman Breeders Association (ABBA).

Brangus: must be registered with the International Brangus Breeders Association (IBBA).

Limousin: must be registered with the North American Limousin Foundation. Must be 7/8 Limousin or greater. Percentage and purebred Limousin shall compete in the same class and championship.

Simbrah: must be purebred and registered with the American Simmental/Simbrah Association (AS/SA). Animals not old enough for registration must be accompanied with properly filled out application for registration, known as a herdhandler.

Simmental: must be purebred and fullblood Simmental and registered with the American Simmental/Simbrah Association (AS/SA).

Shorthorn: must be purebred and registered with the American Shorthorn Association (ASA)

All Other Purebred-American: must have registration papers and have Brahman influence- (Example: Bralers, Brahmousin, Santa Gertrudis).

All Other Purebred-English and Exotic: must have registration papers and be a purebred.

10. No electronic, video, and/or computerized presentations may be used.
11. Projects may not be welded or painted on Brazoria County Fairgrounds. All work must be completed before check-in (assembly only on fairgrounds). **NOTE: All projects and displays will be completed by Saturday at noon.**
12. **Flammable and/or combustible liquids or material are not to be used on any project (paint thinners, petroleum base liquids, etc).** Gasoline and Diesel for motorized equipment must be labeled.
